

**TOWNSHIP OF COLTS NECK
TOWNSHIP COMMITTEE REGULAR MEETING
DECEMBER 19, 2018, 5:00 P.M.
TOWN HALL**

The meeting of the Colts Neck Township Committee was called to order at 5:00 p.m. by Deputy Mayor Orgo followed by a salute to the flag. - 1. COMMENTS FROM THE PUBLIC:** Acting Mayor Orgo called for a motion to open the meeting to public comment. Mr. Viola made a motion to open the meeting to public comment, seconded by Mr. Rizzuto and unanimously carried.
