**RESOLUTION DECLARING COLTS NECK TOWNSHIP A SECOND
AMENDMENT LAWFUL GUN OWNER TOWNSHIP**

WHEREAS, the Second Amendment of the United States Constitution reads, "A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed," and

WHEREAS, the State of New Jersey was the first to ratify the Bill of Rights, including the right to keep and bear arms, and the New Jersey Supreme Court has recognized it as fundamental right of its citizens; and

WHEREAS, Colts Neck Township desires to uphold its oath to the Constitution, and to express its deep commitment to it, to the Bill of Rights and the freedoms guaranteed thereunder; and

WHEREAS, Colts Neck Township desires to express its opposition to any proposed law that infringes on any right protected under the Constitution and Bill of Rights, including the Second Amendment; and

WHEREAS, Colts Neck Township desires to express its intent to comply with all relevant federal and state laws, while also standing with the Constitution, Bill of Rights, and all natural rights guaranteed under its protections, including the Second Amendment, and to use such legal means at its disposal to protect all right of its citizens;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of Colts Neck Township hereby expresses its intent to uphold the rights of all citizens of Colts Neck Township, including those rights protected under the Second Amendment; and

BE IT FURTHER RESOLVED that the Township Committee of Colts Neck Township hereby declares its intent to express opposition to unconstitutional restrictions on the rights of citizens, including those rights protected under the Second Amendment; and

BE IT FURTHER RESOLVED that the Township Committee of Colts Neck Township shall be deemed a "Second Amendment Lawful Gun Owner Township."

BE IT FURTHER RESOLVED that the Municipal Clerk forward a certified true copy of this resolution to the Governor of the State of New Jersey, and the Monmouth County Board of Chosen Freeholders.
