BE IT RESOLVED that a curfew shall hereby be established for all residents and non-residents seventeen years and under within the jurisdiction of Colts Neck Township from the hours of 9:00 p.m. to 5:00 a.m. the following morning, each consecutive night, commencing Friday, October 30, 2020 at 9:00 p.m. until the morning of Sunday, November 1, 2020 at 5:00 a.m., wherein no resident or non-resident minor shall be entitled to be on the streets, thoroughfares and property in Colts Neck Township, other than the property and dwelling wherein said minor resides or is a bona-fide guest of the owner or lessee thereof unless said minor is in the company of an adult of 21 years or older, or traveling to or from a civic, church or school function or employment.

BE IT FURTHER RESOLVED that any juvenile violating the within resolution shall be taken to the Police Headquarters in Colts Neck Township, at which time a telephone call will be directed to his or her parents and/or guardian requesting them to pick up such minor and return him or her to his or her home.

**AUTHORIZING AWARD OF CONTRACT FOR

WHEREAS, under the Local Public Contracts Law N.J.S.A. 40A:11-8 Colts Neck Township issued Notices to Bidders for the Furnishing and Delivering of Leaf Collection Services for the Department of Public Works of Colts Neck Township, which were published in the Asbury Park Press on August 5, 2020 and September 12, 2020 respectively; and

WHEREAS, one bid was received on August 25, 2020 and publicly opened and two bids were received and publicly opened on September 23, 2020 pursuant to law; and

WHEREAS, the Township Committee of Colts Neck Township adopted Resolutions 2020-106 and 2020-118 rejecting all bids pursuant to N.J.S.A 40A:11-13.2, the lowest bid substantially exceeds the budgeted cost estimates; and

WHEREAS, pursuant to N.J.S.A. 40A:11-5, the contract may then be negotiated and may then be awarded by adoption of a resolution by a two-thirds affirmative vote of the authorized membership of the Governing Body; and
